## Terms and Conditions

### Definitions

---

**Arrival date:** the arrival date specified in the booking confirmation or such other date as may be applicable to these conditions.

**Booking:** the reservation made by you and accepted by us in accordance with these conditions and as set out in the booking confirmation:

**Visit:** your visit details of which are set out in the booking confirmation or otherwise agreed in writing by us.

**Payment dates:** fees should be paid at the time of booking.

### Conditions applicable

---

The conditions shall apply to the contract to the exclusion of all other terms & conditions.

Any typographical clerical or other error or omission in any sales literature quotation price list acceptance of offer invoice or other documentation issued by us shall be subject to correction without any liability on our part unless such correction materially affects your rights and obligations to your detriment in which case you shall be entitled to cancel the contract without liability within 14 days of receipt of the notice of such correction. In the event of cancellation in such circumstances you shall be entitled to a refund of any sums paid (except in respect of any services provided). The details published in various brochures and leaflets are compiled from up-to-date and accurate information available at the time of going to press (the print date appearing in each brochure or leaflet).

Nothing in these conditions is intended to nor shall affect your statutory rights.

### Booking procedures

---

Call 01623 860 202 to make a booking, to check availability or make further enquiries. We will need to know a contact name, email address, phone number, postal address, and the numbers in your group.

We will then process your booking; please note we will require full payment at the time of booking and will email you confirmation when complete.

You shall not be entitled to make any alterations to any documentation issued by us. Any alteration to any booking confirmation should be notified to us as soon as possible and in the event we are able to satisfy your requirements we shall send to you a revised booking confirmation.

If you are looking to increase your group size additional payment will be required at the time of the change being agreed.

If you are looking to decrease your group size then please refer to our reductions and cancellations section below for details on cancellation fees

### Reductions and cancellations

---

If you decide to reduce your group size or cancel your booking, you must tell us as soon as possible. You must pay a termination fee which covers our administration costs and compensates us for the risk that we do not resell your booking. The fee is based upon how long before your booking you tell us you want to cancel and is a percentage of the total price of your booking:

### Your responsibilities

---

Behaviour deemed inappropriate may include but is not limited to:

- Theft, vandalism or illegal activities
- Inappropriate behaviour
- Bullying in any form which adversely affects the enjoyment of other visitors

Where we reserve our rights under this clause you must arrange to leave site within 12 hours of our notifying you. Any additional costs so incurred shall be entirely your responsibility.

If any problem is experienced during the visit the matter should be immediately reported to the site CEO to allow us the opportunity to rectify any problem raised. If it is not resolved you should write to us within 28 days of departure and we will endeavour to find a satisfactory solution.
